

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY-2011 Budgets for the Schuk Toak District Administration, Summer Youth Program and for the Nine Communities in the Total Amount of \$1,705,922.80)**

1 **WHEREAS, the Schuk Toak District presented to the Tohono O'odham Legislative Council the**
2 **District's FY - 2011 Budgets in the total amount of \$1,705,922.80; and**

3 **WHEREAS, the Schuk Toak District was allocated Gaming Revenue in the amount of \$1,705,922.80**
4 **for FY - 2011; and**

5 **WHEREAS, the Schuk Toak District Council at a meeting held on Saturday, September 4, 2010 with**
6 **a quorum present, did review and approve the District FY - 2011 budgets; and**

7 **WHEREAS, the District Administration FY-2011 budget was presented for review and approval in**
8 **the amount of \$825,096.80; and**

9 **WHEREAS, the Summer Youth Program FY-2011 budget was presented for review and approval**
10 **in the amount of \$70,826.00; and**

11 **WHEREAS, each of the Nine Communities were allocated \$90,000.00 for a total of \$810,000.00 and**
12 **each community did present their budget for review and approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the Schuk Toak District FY-2011 budgets as outlined:**




