1 **WHEREAS, the Gu-Vo District presented to the Tohono O'odham Legislative Council The District's**
2 **FY' 2011 Budgets for the fiscal year; and**

3 **WHEREAS, the Gu-Vo District was allocated Gaming Revenue in the amount of \$1,705,922.80; and**

4 **WHEREAS, Gu-Vo District Governing Council at a meeting held on August 21, 2010 with a quorum**
5 **present, did review and approve the District FY' 2011 Budgets in the total amount of**
6 **\$1,760,435.02 per attached resolution; and**

7 **WHEREAS, Pursuant to Resolution GV-10-076 "Approving Gu-Vo Community to Carry Over Fiscal**
8 **Year 2006 in the amount of \$3,067.84 and Fiscal Year 2009 in the amount of \$51,444.38**
9 **into Fiscal Year 2011 Budget, the total amount is \$54,512.22; and**

10 **WHEREAS, the Gu-Vo Community's total budget amount for FY' 2011 is \$252,666.96; and**

11 **WHEREAS, the total budget amount for each of the following communities as part of the total FY'**
12 **2011 District Budgets are as follows;**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
24 **approves the Gu-Vo District FY' 2011 Budgets in the amount of \$1,760,435.02.**

6 **affecting the funds or funding levels shall be approved by the Legislative Council.**

8 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**
10 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
11 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
13 **18, 1934 (48 Stat. 984).**
