of the FY2010 revenue funding to the Bank of America Solid Waste Revenue Account)**

**RESOLUTION NO. 10-369**

1 **WHEREAS, the Tohono O'odham Legislative Council approved a dedicated account for the Solid**  
2 **Waste Management Program budget 83-0003 through Resolution No. 98-236; and**

3 **WHEREAS, the Solid Waste Management Program deposits any revenue into Bank of America**  
4 **Account per Resolution No. 05-557; and**

5 **WHEREAS, the Solid Waste Management Program has generated \$350,000.00 revenue from**  
6 **residential and commercial trash collection fees, heavy equipment fees and recycling**  
7 **revenue; and**

8 **WHEREAS, the Solid Waste Management Program will submit a budget amount of \$350,000.00 for**  
9 **the FY2011 budget 83-0003; and**

10 **WHEREAS, the Solid Waste Management Program budget 83-0003 has been reviewed by the**  
11 **Legislative Natural Resources Committee and the Legislative Budget and Finance**  
12 **Committee.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
14 **expenditure of FY2011 revenue in the amount of \$350,000.00 for the Solid Waste**  
15 **Management Program FY2011 budget 83-0003, from October 1, 2010 through**  
16 **September 30, 2011, in accordance with the budget attached hereto.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Nation's Officials, to wit: the Chairperson and any designated official are authorized**  
19 **to negotiate and execute the agreement, provided however, that any amendments**  
20 **affecting the funds or funding levels of the agreement shall be submitted for further**  
21 **approval.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day**  
23 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**  
25 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat. 984).**
