**(Authorization to Carry Forward and Expend \$196,013.59 from Indian Health Service**  
**(I.H.S.) Memorandum of Agreement of the Solid Waste Management Program FY 2011**  
**ARRA - I.H.S. Budget 11-1124 for a six month period to March 31, 2011)**

RESOLUTION NO. 10-372

1 **WHEREAS, the Tohono O'odham Legislative Council approved a Memorandum of Agreement**  
2 **between the Solid Waste Management Program and the Indian Health Service through**  
3 **Resolution No. 97-041; and**

4 **WHEREAS, the Solid Waste Management Program will submit a FY 2011 ARRA - I.H.S. budget for**  
5 **dump closure in the amount of \$196,013.59 for a six month period through March 31,**  
6 **2011; and**

7 **WHEREAS, the Solid Waste Management Program budget FY2011 ARRA - I.H.S. budget 11-1124 has**  
8 **been reviewed by the Legislative Natural Resources Committee and the Legislative**  
9 **Budget and Finance Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
11 **expenditure of \$196,013.59, from the I.H.S. Memorandum of Agreement, for the Solid**  
12 **Waste Management FY2011 ARRA - I.H.S. budget 11-1124, in accordance with the six**  
13 **month budget attached hereto.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
15 **Nation's Officials, to wit: the Chairperson and any designated official are authorized**  
16 **to negotiate and execute the agreement, provided however, that any amendments**  
17 **affecting the funds or funding levels of the agreement shall be submitted for further**  
18 **approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day**  
20 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**  
22 **VI, Section 1 (d)(2)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**


