7	WHEREAS, the Solid Waste Management Program budget FY2011 ARRA-I.H.S. budget 11-1124 has
8	been reviewed by the Legislative Natural Resources Committee and the Legislative
9	Budget and Finance Committee.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the
11	expenditure of \$196,013.59, from the I.H.S. Memorandum of Agreement, for the Solid
12	Waste Management FY2011 ARRA - I.H.S. budget 11-1124, in accordance with the six
13	month budget attached hereto.
14	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
15	Nation's Officials, to wit: the Chairperson and any designated official are authorized
16	to negotiate and execute the agreement, provided however, that any amendments
17	affecting the funds or funding levels of the agreement shall be submitted for further
18	approval.
