**(Approving FY 2009 Pisinemo District Mining Royalty Carry Over in the amount of \$48,066.27)**

**RESOLUTION NO. 10-374**

1 **WHEREAS, the Tohono O'odham Legislative Council at a regularly scheduled meeting discussed**  
2 **the Pisinemo District FY 2009 Mining Royalty Budget; and**  
3 **WHEREAS, the Legislative Council was provided information on balances remaining within the**  
4 **FY 2009 Mining Royalty Budget; and**  
5 **WHEREAS, the remaining balance of \$48,066.27 will assist the District to continue providing much**  
6 **needed services and assistance for District members; and**  
7 **WHEREAS, the District Administration has submitted a budget proposal to amend and carry over**  
8 **the remaining \$48,066.27 of FY 2009 Mining Royalty budget into fiscal year 2011.**  
9 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council approves the**  
10 **request to carry over Pisinemo District FY 2009 Mining Royalty budget in the amount**  
11 **of \$48,066.27 into fiscal year 2011.**  
12 **BE IT FINALLY RESOLVED that any amendments affecting the funds or funding level of this**  
13 **budget shall be submitted to the Tohono O'odham Legislative Council for further prior**  
14 **approval.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day**  
16 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
17 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**  
18 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
19 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**
