**RESOLUTION NO. 10-375**

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 10-290 approved FY 2011 District**  
2 **Allocation and Apportionment of Gaming Revenues to Districts by equal distributions;**  
3 **and**

4 **WHEREAS, Pisinemo District FY 2011 budget in the amount of \$1,705,922.80 was presented to the**  
5 **Legislative Council for review, comment and recommendations; and**

6 **WHEREAS, Pisinemo District FY 2011 budget was also taken out to the communities of San Simon,**  
7 **Pisinemo, Santa Cruz, Kupk and Dirtburn for review and comments and then brought**  
8 **back to the Pisinemo District Council for action; and**

9 **WHEREAS, the respective communities and Pisinemo District Council have approved the FY 2011**  
10 **District Budget to be distributed as follows:**

12	<b>Fringe Benefits</b>	<b>\$220,093.11</b>
13	<b>District Operations</b>	<b>\$651,452.48</b>

16 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approve the**  
17 **Pisinemo District FY 2011 District Budget in the amount of \$1,705,922.80.**

18 **BE IT FURTHER RESOLVED that any amendments affecting the funds or funding levels of this**  
19 **budget shall be submitted to the Tohono O'odham Legislative Council for further prior**  
20 **approval.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day**  
22 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**  
24 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
