

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2011 Budgets for Baboquivari District Administration and the Communities**  
**of Artesia/Little Tucson, Choulic, Coldfields, Fresnal Canyon, South Komelic, and Topawa)**

**RESOLUTION NO. 10-377**

- 1 **WHEREAS, at a regular scheduled session of the Tohono O'odham Legislative Council, held on**  
2 **September 15, 2010; and**
- 3 **WHEREAS, Baboquivari District officials presented their FY 2011 budgets for the District**  
4 **Administration, and the communities of Artesia/Little Tucson, Choulic, Coldfields,**  
5 **Fresnal Canyon, South Komelic, Topawa; and**
- 6 **WHEREAS, on July 27, 2010, the Tohono O'odham Nation, per Resolution No. 10-290, approved to**  
7 **distribute gaming revenues to the Nation's Districts by equal distribution; and**
- 8 **WHEREAS, by equal distribution, the Baboquivari District will receive an amount of \$1,705,922.80;**  
9 **and**
- 10 **WHEREAS, the Tohono O'odham Legislative Council recognizes the Baboquivari District's**  
11 **Resolution No. 2010-B-94 to utilize a 40%/60% formula to distribute gaming revenues**  
12 **within their District; and**
- 13 **WHEREAS, utilizing this formula, \$682,369.12 is the calculated amount for Baboquivari District**  
14 **Administration budget at 40%; and**
- 15 **WHEREAS, utilizing this same formula, at 60%, the calculated amount of \$1,023,553.68 shall be**  
16 **divided equally to the six communities of Baboquivari District, for a distribution of**  
17 **\$170,592.28 per community; and**
- 18 **WHEREAS, the Artesia/Little Tucson Community requests to carry forward their portion of Mining**  
19 **Royalties, per Baboquivari District Resolution No. 09-B-163, in the amount of**  
20 **\$17,741.37; and**
- 21 **WHEREAS, the Artesia/Little Tucson Community will include in their distribution of \$170,592.28,**  
22 **their portion of Mining Royalties of \$17,741.37, for a total budget of \$188,333.65.**
- 23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
24 **the FY 2011 budget of \$1,705,922.80 for Baboquivari District Administration and the**  
25 **six communities of Artesia/Little Tucson, Choulic, Coldfields, Fresnal Canyon, South**  
26 **Komelic, and Topawa, utilizing a formula of 40% to Baboquivari District**  
27 **Administration in the amount of \$682,369.12, and 60% to the six communities in the**  
28 **amount of \$1,023,553.68, divided equally, to the communities, in the amount of**  
29 **\$170,592.28 per community.**

1 **BE IT FURTHER RESOLVED** this budget will also include carry forward Mining Royalties of  
2 **\$17,741.37** for the Artesia/Little Tucson Community for a budget amount of  
3 **\$188,333.65**, and for a total FY 2011 budget amount of **\$1,723,664.17** for the  
4 **Baboquivari District.**

5 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the  
6 **District Chairperson and any designated official to expend and administer the budgets**  
7 **as attached, provided that any amendments affecting the funds or funding level shall**  
8 **be submitted for further prior approval by the Budget & Finance Committee and the**  
9 **Tohono O'odham Legislative Council.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day**  
11 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,317.30 FOR; 79.50**  
12 **AGAINST; 198.70[02] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council**  
13 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
14 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
16 **18, 1934 (48 Stat. 984).**
