

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the San Xavier District Budget for the Fiscal Year beginning on**  
**October 1, 2010 and ending September 30, 2011)**

**RESOLUTION NO. 10-379**

1 **WHEREAS, on September 1, 2010 the Tohono O'odham Legislative Council's Budget and Finance**  
2 **Committee reviewed the San Xavier District's projected expenditures for the fiscal**  
3 **year ending on September 30, 2011; and**

4 **WHEREAS, the San Xavier District Council intends to utilize its gaming revenues and general**  
5 **operating funds to meet the projected budget amount outlined in the attached fiscal**  
6 **year 2011 budget; and**

7 **WHEREAS, the proposed budget of \$13,669,551.34 was reviewed and approved by majority vote of**  
8 **the San Xavier District members present at the Special District Community meeting**  
9 **held on August 21, 2010.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby with the**  
11 **authority granted under the Tohono O'odham Constitution Article IX, Section 7,**  
12 **approves the San Xavier District's fiscal year 2011 budget in the amount of thirteen**  
13 **million six hundred sixty nine thousand, five hundred fifty one dollars and thirty four**  
14 **cents.**

15 **BE IT FURTHER RESOLVED that the above total amount will be derived from two sources: gaming**  
16 **revenues in the amount of \$4,965,422.90 and San Xavier District general operating**  
17 **funds in the amount of \$8,704,128.44.**

18 **BE IT FINALLY RESOLVED that any amendments affecting the funds or funding levels of the budget**  
19 **shall be approved by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day**  
21 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and 187.10[05] ABSENT, pursuant to the powers vested in the Council**  
23 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
24 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**
