

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving SAWRSA Purchased Equipment Insurance Budget for fiscal year 2011)**

RESOLUTION NO. 10-383

1 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Legislative Council authorized San**
2 **Xavier Cooperative Association to perform maintenance for the completion of bank**
3 **stabilization of the Santa Cruz River; and**

4 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Nation purchased equipment and**
5 **materials necessary for the project and the Nation assume financial responsibility of**
6 **the yearly insurance cost on such equipment; and**

7 **WHEREAS, pursuant to Section .309 (a) of the Southern Arizona Water Rights Settlement Act of**
8 **1982 ("SAWRSA") the Tohono O'odham Nation (the "Nation") received \$15,000,000.00**
9 **to be held in trust by the Nation (the "SAWRSA Trust Fund"); and**

10 **WHEREAS, under Section .309 (b) of SAWRSA, the Nation may expend accrued interest and**
11 **dividends on the SAWRSA Trust Fund "for the subjugation of land, development of**
12 **water resources, and the construction, operation, maintenance, and the replacement**
13 **of related facilities on the Papago Reservation (now known as the Tohono O'odham**
14 **Reservation) which are not the obligation of the United States under this (SAWRSA) or**
15 **any other Act of Congress"; and**

16 **WHEREAS, the San Xavier Cooperative Association has agreed to pay for the yearly maintenance**
17 **costs of the equipment and requests that the Nation pay for the yearly insurances costs**
18 **per Resolution No 08-96; and**

19 **WHEREAS, the Equipment Insurance Budget qualify for the funding under the SAWRSA Trust**
20 **Fund; and**

21 **WHEREAS, the San Xavier District has prepared the attached budget for Fiscal Year 2011 in the**
22 **amount of \$6,089.00 and funded from the SAWRSA Trust Fund.**

23 **NOW, THEREFORE, BE IT RESOLVED that:**

- 24 **1. The Tohono O'odham Legislative Council hereby approves the San Xavier**
25 **Cooperative Association Maintenance and Operational Equipment Insurance**
26 **Budget in the amount of \$6,089.00 for fiscal year 2011, in the form attached hereto.**
27 **2. The Legislative Council appropriates the sum of \$6,089.00 from the SAWRSA Trust**
28 **Fund to fund the Equipment Insurance Budget for fiscal year 2011.**

4 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-**
5 **AGAINST; -01- NOT VOTING; and 187.10[05] ABSENT, pursuant to the powers vested in the Council**
6 **by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
7 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
8 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
9 **18, 1934 (48 Stat. 984).**
