

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Sif-Oidak FY 2011 Gaming Revenue Budget in the Amount**  
**of \$1,705,922.80)**

**RESOLUTION NO. 10-385**

1 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 10-289,**  
2 **"Appropriating Desert Diamond Savings to Supplement the FY 2011 Gaming**  
3 **Distribution to the Districts in the amount of \$5,500,896.00"; and**

4 **WHEREAS, the Tohono O'odham Legislative Council also enacted Resolution No. 10-290,**  
5 **"Approving FY 2011 District Allocation and Apportionment of Gaming Revenues to**  
6 **Districts by Equal Distribution"; and**

7 **WHEREAS, the apportionment for each of the Districts by equal distribution is in the amount of**  
8 **\$1,705,922.80; and**

9 **WHEREAS, the Sif-Oidak District Council, on August 28, 2010, enacted Resolution No. SODC 10-149,**  
10 **"Approving the FY 2011 Sif-Oidak District Gaming Revenue Budget in the amount of**  
11 **\$1,705,922.80"; and**

12 **WHEREAS, on September 1, 2010, the Budget & Finance Committee of the Legislative Council**  
13 **reviewed the FY 2011 Sif-Oidak District Gaming Revenue Budget; and**

14 **WHEREAS, the Sif-Oidak District Council, on September 15, 2010, made some revisions to the FY**  
15 **2011 Administrative Budget and passed Resolution No. SODC 10-159; however, the**  
16 **bottom line total still remains the same.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**  
18 **approve the Sif-Oidak district FY 2011 Gaming Revenue Budget as attached in the**  
19 **amount of \$1,705,922.80.**

20 **BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or funding**  
21 **levels that it shall be approved by the Tohono O'odham Legislative Council prior to any**  
22 **expenditures.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day**  
24 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 1,419.0 FOR; 159.0**  
25 **AGAINST; 830.40[06] NOT VOTING; and 187.10[06] ABSENT, pursuant to the powers vested in the**  
26 **Council by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**  
27 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**  
29 **of June 18, 1934 (48 Stat. 984).**
