10	"Approving the FY 2011 Sif-Oidak District Gaming Revenue Budget in the amount of
11	\$1,705,922.80"; and
12	WHEREAS, on September 1, 2010, the Budget & Finance Committee of the Legislative Council
13	reviewed the FY 2011 Sif-Oidak District Gaming Revenue Budget; and
14	WHEREAS, the Sif-Oidak District Council, on September 15, 2010, made some revisions to the FY
15	2011 Administrative Budget and passed Resolution No. SODC 10-159; however, the
16	bottom line total still remains the same.
17	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby
18	approve the Sif-Oidak district FY 2011 Gaming Revenue Budget as attached in the
19	amount of \$1,705,922.80.
20	BE IT FINALLY RESOLVED that in the event there should be any changes in the funding or funding
21	levels that it shall be approved by the Tohono O'odham Legislative Council prior to any
22	expenditures.

26	Council by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation,

28	Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
