

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting October 8, 2010 Special Session for the Tohono O'odham Ki:Ki Association to  
Present Its Annual Performance Report)**

**LEGISLATIVE ORDER NO. 10-386**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**  
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**  
4 **Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with**  
6 **the authority to "by majority vote, call for a special session" (Legislative Rules of the**  
7 **Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, pursuant to Article X, of Ordinance No. 98-03, "Establishment of Tohono O'odham Ki:ki**  
9 **Association" (as amended),**

10 **2. The TOKA shall provide Annual Reports to the Tohono O'odham Legislative**  
11 **Council, and the Tohono O'odham Nation's Chairman, which will include a**  
12 **summary of the accomplishments, problem areas, financial conditions, unit**  
13 **availability, and an overall evaluation of its ability to meet the goals and**  
14 **objectives of the 1 Year Indian Housing Plan on a timely basis.**

15 **a. The reports may include proposed corrective actions to bring the programs**  
16 **into compliance, or amendments that provide program adjustments to**  
17 **allow orderly progress and success.**

18 **3. The TOKA shall provide an Annual Report to the Tohono O'odham Legislative**  
19 **Council, the Nation's Chairman, and the Department of HUD. The Annual Report**  
20 **will reflect the affordable housing assistance program and project**  
21 **accomplishments, along with a detailed report of the financial status of each**  
22 **major activity implemented to meet the 1 Year Plan's goals and objectives."; and**

23 **WHEREAS, the Legislative Council Housing Committee has requested a special session for**  
24 **October 8, 2010 at 9:00 a.m. for the Tohono O'odham Ki:Ki Association to present its**  
25 **Annual Performance Report.**

26 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
27 **special session for October 8, 2010 at 9:00 a.m. for the Tohono O'odham Ki:Ki**  
28 **Association to present its Annual Performance Report.**

29 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> day of**  
30 **SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-**  
31 **AGAINST; -0- NOT VOTING; and 187.10[06] ABSENT, pursuant to the powers vested in the Council**  
32 **by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**  
33 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35 **18, 1934 (48 Stat. 984).**
