

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2011 Budget for Sells District Administration and its
four Communities in the amount of \$1,705,922.80)**

RESOLUTION NO. 10-387

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 10-290 approved the**
2 **distribution of Gaming Revenues in the amount of \$1,705,922.80 to each of the eleven**
3 **Districts of the Tohono O'odham Nation; and**

4 **WHEREAS, each of the four communities of Sells District prepared and submitted the attached**
5 **community approved budgets in accordance to their needs; and**

6 **WHEREAS, the budget and it's justification prepared by the District Administration in the amount**
7 **of \$1,080,922.80 was presented to and approved by each of the four communities; and**

8 **WHEREAS, Sells District Council did review and approve the Sells District Administration Budget**
9 **and the attached budgets for each of the four communities of the Sells District with**
10 **Resolution No. SD-74-10 for a total amount of \$1,705,922.80; and**

11 **WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee and the Tohono**
12 **O'odham Legislative Council did review and approve Sells District Administration**
13 **Budget and the budgets for each of the four communities.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves Sells**
15 **District Fiscal Year 2011 Budget for the District Administration and its four**
16 **communities as submitted in the attached budgets and its justifications to be effective**
17 **October 1, 2010 according to the following:**

District Administration	\$1,080,922.80
Cowlic Community	\$ 190,100.00
Ge Oidag Community	\$ 184,900.00
North Communities	\$ 100,000.00
Sells Community	\$ 150,000.00

23 **for a total budget in the amount of \$1,705,922.80 from Gaming Revenues.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
25 **District Chairperson and any designated District official to expend and administer the**
26 **budget according to its justification as attached, provided that any**
27 **modifications/amendments affecting the funds or funding levels of the budget shall**
28 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**
