9	WHEREAS, the Hikiwan District Council by Resolution No. HDC-10-051 accepted and approved the
10	FY2011 Budgets for the following communities: Gehakah, Ventana, Vaya Chin, S-tuha
11	Bidag, South Hikiwan, and Schuchuligk in the amount of \$37,000 for each community
12	for a total of \$222,000.00; and
13	WHEREAS, by Resolution No, HDC-10-053, the Hikiwan District Council accepted and approved
14	the FY2011 Budget for the Hodai Son Vo'o Community in the amount of \$37,000.00
15	bringing the total of Community budgets to a total of \$259,000.00; and
16	WHEREAS, the total FY2011 Budget for the Hikiwan District Administration, \$1,498,919.88, and
17	seven Communities in the amount of \$259,000 bringing a total of \$1,757,919.88.
18	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and
19	approves the FY2011 Budgets for the Hikiwan District Council in the amount of
20	\$1,757,919.88 for the Hikiwan District Administration and seven communities.
21	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
22	Chairperson and any designated official to expend and administer the budget as
23	attached; provided that any amendments affecting the funds of funding level shall be
24	submitted for further prior approval by the Tohono O'odham Legislative Council.
25	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $17^{ m TH}$ Day
26	of <u>SEPTEMBER</u> , 2010 at a meeting at which a quorum was present with a vote of <u>2,285.90</u> FOR; <u>79.50</u>

28	by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted
