

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving San Lucy District to Continue District Operations and Expenses Pursuant  
to Resolution Number 09-600 "Approving the San Lucy FY 2010 Budget" Pending  
Approval of the San Lucy District FY 2011 Budget)**

RESOLUTION NO. 10-390

1 WHEREAS, pursuant to the Tohono O'odham Nation Constitution Article VI, Section 1(d)(2) and (3)  
2 the Tohono O'odham Council has the fiscal powers to manage funds, and to  
3 appropriate funds for the benefit of the nation and its members, and to adopt, approve  
4 and amend annual budgets and to authorize the expenditure of funds....budgets; and

5 WHEREAS, San Lucy District has attested that sufficient funds are available to continue district  
6 operations pending approval of the FY 2011 budget; and

7 WHEREAS, the San Lucy District Council by District Resolution Number SL 09-99-10 approved to  
8 continue district operations and expenses pursuant to the Tohono O'odham  
9 Legislative Council Resolution Number 09-600 that would allow the district complete  
10 the FY 2011 Budget; and

11 WHEREAS, in consideration of the request from the San Lucy District Council, the Tohono  
12 O'odham Legislative Council has determined it would be in the best interest of the  
13 district and Nation to continue district operations and services.

14 NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves the  
15 San Lucy District to continue district operations and expenses pursuant to Tohono  
16 O'odham Legislative Council resolution number 09-600; and the San Lucy District has  
17 attested there are sufficient funds available to continue district operations.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup> Day  
19 of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-  
20 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article  
21 VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the  
22 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
24 18, 1934 (48 Stat. 984).
