

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Intergovernmental Agreement between the Tohono O'odham Nation and
the Arizona Board of Regents, University of Arizona, Regarding the Development of
a Long Range Plan for the Tohono O'odham Nation)

RESOLUTION NO. 10-392

1 **WHEREAS, the Nation understands the need for a shared Tohono O'odham vision that addresses**
2 **not only the immediate needs of the Nation but those that are twenty years into the**
3 **future; and**

4 **WHEREAS, no formally recognized long range planning document is currently in place that helps**
5 **develop or articulate this vision; and**

6 **WHEREAS, the Nation recognizes the importance of the development of a long range plan and the**
7 **Planning & Economic Development Department has been directed to develop such a**
8 **plan for the Nation; and**

9 **WHEREAS, the Planning & Economic Development Department has identified the University of**
10 **Arizona, School of Landscape Architecture & Planning to assist the Nation in activities**
11 **related to the development of the long range plan; and**

12 **WHEREAS, the long range plan will involve the elements of: Land Use, Circulation, Growth Area,**
13 **Environmental Planning, Cost of Development, Open Space, Water Resources,**
14 **Economic Development, Energy, Conservation, Recreation, Public Services &**
15 **Facilities, Housing, and Safety; and**

16 **WHEREAS, the Nation's Eleven (11) Districts may elect to, or not to, participate with developing**
17 **this long range plan; and**

18 **WHEREAS, the attached IGA has been reviewed by the Commerce, the Natural Resources and the**
19 **Domestic Affairs Committees which recommend approval by the Tohono O'odham**
20 **Legislative Council.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **Intergovernmental Agreement (IGA) with the University of Arizona substantially in the**
23 **form attached hereto.**

24 **BE IT FURTHER RESOLVED that the University of Arizona and the Tohono O'odham Nation's**
25 **Planning & Economic Development Department work closely with each of the Tohono**
26 **O'odham Nation's Eleven (11) Districts in an effort to accomplish the provisions of this**
27 **Intergovernmental Agreement.**

28 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation's Eleven (11) District's may elect to,**
29 **or not to, participate with developing this long range plan.**

1 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairman is authorized to execute the**
2 **IGA and any subsequent amendments to extend the term of the IGA provided that any**
3 **amendments affecting the funds or funding level shall be submitted for further**
4 **approval by the Tohono O'odham Legislative Council.**

5 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH Day**
6 **of SEPTEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,436.50 FOR; -0-**
7 **AGAINST; 159.0 [01] NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council**
8 **by Article VI, Section 1 (f) and (i) of the Constitution of the Tohono O'odham Nation, adopted by the**
9 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
10 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
11 **18, 1934 (48 Stat. 984).**
