

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2011 Lobbying Contract with Patton Boggs LLP)**

RESOLUTION NO. 10-397

1 **WHEREAS, the Legislative Council is vested with the power to “consult with the Congress of the**
2 **United States and appropriate federal agencies regarding federal activities that affect**
3 **the Tohono O’odham Nation and all federal appropriation estimates and projects for**
4 **the benefit of the Tohono O’odham Nation before such estimates and projects are**
5 **submitted to Congress and other federal agencies” (Constitution of the Tohono**
6 **O’odham Nation, Article VI, Section 1(j)); and**

7 **WHEREAS, the Legislative Council is further vested with the power to “employ legal counsel for**
8 **the protection and advancement of the rights of the Tohono O’odham Nation”**
9 **(Constitution of the Tohono O’odham Nation, Article VI, Section 2(a)); and**

10 **WHEREAS, it is in the Nation’s interest to employ a lobbyist in Washington, D.C. to effectively**
11 **consult with the Congress and federal agencies; provide advice regarding federal**
12 **appropriations, legislation, and programs; and, when authorized, act as a liaison**
13 **between the Nation and the United States; and**

14 **WHEREAS, the Nation’s federal lobbying contract with Patton Boggs LLP expires on September 30,**
15 **2010; and**

16 **WHEREAS, the firm of Patton Boggs LLP is qualified to provide advice and representation as the**
17 **Nation’s federal lobbyist; and**

18 **WHEREAS, a federal lobbying contract, including an Exhibit A “FY 2011 Billing Rates Schedule,”**
19 **a retainer letter dated September 28, 2010, and “Standard Terms of Engagement for**
20 **Legal Services” (collectively, “Lobbying Contract”), has been negotiated with Patton**
21 **Boggs LLP (the “Attorneys”) and has been reviewed by the Legislative Appropriations,**
22 **Domestic Affairs, and Budget and Finance Committees.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council hereby:**

- 24 **1. Approves the Lobbying Contract in the amount of \$150,000 with the Attorneys in**
25 **substantially the form attached hereto for the period commencing on October 1,**
26 **2010 and ending on March 31, 2011.**
- 27 **2. Authorizes the Nation’s Chairperson to execute the Lobbying Contract with the**
28 **Attorneys.**
