7	WHEREAS, the Legislative Council approved the FY 2011 Executive Branch Administrative Lobby
8	Budget, line item 811-Lobby, which funds federal and state lobbying services; and
9	WHEREAS, the Nation's Chairperson, in consultation with the Appropriations Committee,
10	recommends that Triadvocates, LLC be retained as a governmental relations
11	consultant for matters involving State of Arizona legislative, administrative,
12	appropriations, lobbying, and agency activities, as well as State of Arizona local and
13	municipal governmental activities, that may affect the Nation in accordance with the
14	attached Governmental Relations Representation Contract with Triadvocates, LLC
15	("Contract") for the period commencing October 1, 2010 and ending March 31, 2011.
16	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:
17	1. Approves the Contract with Triadvocates, LLC in the amount of \$90,000 for the
18	period commencing October 1, 2010 and ending March 31, 2011 in substantially the
19	form attached hereto; provided that the Contract shall be funded from the FY 2011
20	Executive Branch Administrative Lobby Budget, line item 811-Lobby; and
21	2. Authorizes the Nation's Chairperson to execute the Contract.
