

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Lucy District FY 2011 Budget)

RESOLUTION NO. 10-399

1 **WHEREAS, the Tohono O'odham Legislative Council pursuant to authority of the Tohono**
2 **O'odham Constitution has exclusive powers over the management of Nation's funds**
3 **and to appropriate these funds for the benefit of the Nation and its members; and**

4 **WHEREAS, annually funds gaming revenues are apportioned to each district for budgetary**
5 **purposes and for FY 2011 each district was allocated \$1,705,922.80; and**

6 **WHEREAS, the San Lucy District Council met with district program managers and supervisor in**
7 **preparation of the new fiscal year budget, and on Thursday 16 September presented**
8 **final draft version of the budget to the community for comments. At the conclusion**
9 **of the budget presentation, the San Lucy District Council with a motion and seconded**
10 **approved the FY 2011 San Lucy District Budget, Resolution Number SL 09-101-10; and**

11 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance committee have**
12 **reviewed the San Lucy District FY 2011 budget and agreed to forward the budget to the**
13 **legislative council for consideration.**

14 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves San**
15 **Lucy District FY 2011 Budget in the amount of \$2,655,644.38, and said budget approval**
16 **shall be retro-active to October 1, 2010 and end September 30, 2011.**

17 **BE IT FURTHER RESOLVED the Tohono O'odham Legislative Council hereby appropriates**
18 **\$1,705,922.80 from Gaming Revenues reserved for San Lucy District; \$64,103.46 from**
19 **IDC recovered by San Lucy District; carry over amount of \$49,520.46; balance of**
20 **interest earned from gaming account \$612.91; \$835,484.75 from P.L. 99-503 to fund the**
21 **FY 2011 San Lucy District Budget.**

22 **BE IT FINALLY RESOLVED that bi-weekly disbursement of P.L. 99-503 funds are wired transferred**
23 **to the San Lucy District General Account National Bank of Arizona – Gila Bend Branch.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
25 **of OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 2,436.50 FOR; -0-**
26 **AGAINST; -0-NOT VOTING; and 159.0[06] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**
