4 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council does hereby**
5 **recognize that the above-named person(s) have relinquished their membership in this**
6 **Nation, and does hereby order that their name(s) be deleted from the membership**
7 **roll.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
9 **of OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
10 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
11 **II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'odham Nation,**
12 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
13 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
14 **of June 18, 1934 (48 Stat. 984).**
