

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Certification of Eligible Adult Members and Authorizing the Initial
Expenditure of Funds for Per Capita Payments under the Initiative)

RESOLUTION NO. 10-404

1 **WHEREAS, on June 28, 1997 the voters of the Tohono O'odham Nation (the Nation) approved**
2 **Initiative No. IN-01-97 (the "Initiative"); and**

3 **WHEREAS, the Initiative authorized funding from Gaming Revenues for several measures,**
4 **including a one-time per capita distribution of \$2,000.00 to each member of the**
5 **Nation enrolled on June 28, 1997 (the Initial Per Capita Distribution); and**

6 **WHEREAS, pursuant to Resolution No. 97-451, the Tohono O'odham Legislative Council adopted**
7 **an Initiative Funding and Implementation Plan (the FIP) which authorized the**
8 **establishment of set-aside accounts for the Initial Per Capita Distribution and other**
9 **Initiative measures, and set certain conditions on the expenditure of funds from such**
10 **accounts; and**

11 **WHEREAS, pursuant to Resolution No. 97-478, the Tohono O'odham Legislative Council approved**
12 **the transfer of funds from the Desert Diamond Savings Account to certain designated**
13 **set-aside accounts established at Bank of America, including the sum of \$41.5 million**
14 **to a set-aside for the Initial Per Capita Distribution (the Per Capita Account); and**

15 **WHEREAS, three of the conditions to expenditure of the Per Capita Account specified in the FIP**
16 **are (1) approval by the Secretary of the Interior of a Per Capita Distribution plan (the**
17 **Revenue Allocation Plan) pursuant to the requirements of the Indian Gaming**
18 **Regulatory Act, 25 U.S.C. §2710 (b) (3); (2) acceptance by the Tohono O'odham**
19 **Legislative Council of a Certification of Eligible Members submitted by the**
20 **Enrollment Office and based upon receipt of a properly completed and filed**
21 **Certificate of Eligibility Verification for a Per Capita Payment for each member; and**
22 **(3) as to each Minor Eligible Member, establishment of a restricted account at Bank**
23 **of America for the deposit of such Member's Per Capita Payment; and**

24 **WHEREAS, pursuant to Resolution No. 97-452, the Tohono O'odham Legislative Council adopted**
25 **a Revenue Allocation Plan and caused the Plan to be submitted for approval by the**
26 **Phoenix Area Office of the Bureau of Indian Affairs in accordance with authority**
27 **delegated to the Area Office by the Secretary of the Interior; and**

28 **WHEREAS, by letter dated December 18, 1997 the Area Office approved the Revenue Allocation**
29 **Plan with respect to the Initial Per Capita Distribution and disapproved the Plan with**

1 respect to the Biennial Per Capita Payments; and

2 **WHEREAS, pursuant to Resolution No. 2000-472 the FIP was amended by Amendment No. 1 and**
3 **further amended by Amendment 2; and Amendment No. 2 requires an Agreement**
4 **with a reputable financial institution for the establishment of restricted accounts for**
5 **Minor Eligible Members; and**

6 **WHEREAS, an Agreement has been negotiated with Wells Fargo for the establishment of**
7 **restricted accounts for Minor Eligible Members; and**

8 **WHEREAS, the Tohono O'odham Legislative Council has accepted and approved Certifications**
9 **of Eligible Members for the Initial Per Capita Distribution, and disbursements have**
10 **been made to such Members; and**

11 **WHEREAS, the Enrollment Office has filed with the Tohono O'odham Legislative Council a**
12 **Certification of Eligible Members listing 3 adult member who are eligible for receipt**
13 **of the Initial Per Capita Distribution; and**

14 **WHEREAS, all conditions under the applicable laws of the United States and the Nation have**
15 **been satisfied to permit the disbursement of the Initial Per Capita Distribution to the**
16 **Members listed in the Certification of Eligible Members.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 18 **1. Accepts and approves the Certification Listing for 3 eligible adult member for the**
19 **Initiative Per Capita approved listing payout distribution.**
- 20 **2. Authorizes (a) the transfer of \$6,000.00 from the Initiative Per Capita Investment**
21 **Account to the Initiative Per Capita Checking Account established at Bank of**
22 **America; and (b) upon the authorized signature of the Nation, issuance of a check**
23 **on the Initiative Per Capita Checking Account in the amount of (i) \$2,000.00 to each**
24 **Eligible Member residing in the United States and listed in the Certification Listing**
25 **of Eligible Members and (ii) \$1,400.00 to each Eligible Member residing outside the**
26 **United States and listed in the Certification Listing of Eligible Members, with the**
27 **Balance of \$600.00 withheld and remitted to the Internal Revenue Service**
28 **pursuant to the requirements of federal law.**
- 29 **3. Authorizes the Chairman of the Nation to execute such other documents as may be**
30 **necessary to implement this Resolution.**

1 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of**
2 **funds to each additional eligible adult Tohono O'odham member is contingent upon**
3 **verification of a member by the Enrollment Program and further certification of**
4 **additional eligible members by the Tohono O'odham Legislative Council.**

5 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11th Day**
6 **of OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
7 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**
8 **1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
9 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
10 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
11 **18, 1934 (48 Stat. 984).**
