

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Moving November 2010 General Session and Amending Legislative Council Calendar)**

LEGISLATIVE ORDER NO. 10-415

1 **WHEREAS, the Legislative Council is vested with the power “to establish rules and procedures to**
2 **regulate all meetings of the Tohono O’odham Council, standing committees, boards**
3 **and special committees.” (Constitution of the Tohono O’odham Nation, Article VI,**
4 **Section 1(a)); and**

5 **WHEREAS, the Legislative Rules vests the Council with the authority to adopt a legislative**
6 **calendar which shall “specify dates for the general sessions and committee meetings,**
7 **recess periods, recognized holidays and the dates of adjournment” and which shall**
8 **“not be changed without Legislative Council approval.” (Legislative Rules of the**
9 **Tohono O’odham Legislative Council, Article I, Section 1(A)(1) and Section 1(A)(2)); and**

10 **WHEREAS, pursuant to Legislative Order No. 10-181 the Council has adopted its Legislative**
11 **Calendar for June 2010 - June 2011; and**

12 **WHEREAS, it is in the best interest of the Legislative Council to move the November 2010 General**
13 **Session from November 15-19, 2010 to November 3-5, 2010 and continuing November**
14 **8-9 as necessary to complete agenda items approved by the Legislative Council.**

15 **NOW, THEREFORE, BE IT ORDERED by the Tohono O’odham Legislative Council that it hereby**
16 **moves the November 2010 General Session from November 15-19, 2010 to November**
17 **3-5, 2010 and continuing November 8-9 as necessary to complete agenda items**
18 **approved by the Legislative Council.**

19 **BE IT FINALLY ORDERED that legislative committee meetings will be held November 15-19, 2010**
20 **and the Legislative Council Calendar for June 2010 - June 2011 is amended in**
21 **accordance with this order.**

22 **The foregoing Order was passed by the Tohono O’odham Legislative Council on the 13TH day of**
23 **OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 1,742.45 FOR; 853.05**
24 **AGAINST; [03] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (a) of Article VI of the Constitution of the Tohono O’odham Nation, adopted by the Tohono**
26 **O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
