4		has for some years selected the Bank of America as the custodian and manager of the
5		Nation's invested funds, and has made investment decisions based on the advice of the
6		Bank of America; and
7	WHEREAS,	in FY 2009, the Nation retained Portfolio Evaluations, Inc., as an independent
8		investment consultant to advise the Nation regarding the investment choices made
9		or recommended by the Bank of America and by any subsequent or additional
10		investment advisors that may be retained by the Nation; and
11	WHEREAS,	the Investment Committee, Budget & Finance Committee and the Domestic Affairs
12		Committee are recommending extending Portfolio Evaluation's contract until
13	<b>:</b>	September 30, 2011; and
14	WHEREAS,	under the contract, the Investment Consultant will report as reasonably necessary to
15		the Investment Committee and will, at a minimum, provide two presentations to the
16		full Legislative Council per year; and
17	WHEREAS,	the term of the contract will be from October 1, 2010 through September 30, 2011, and
18		the financial arrangement will be a flat retainer fee of \$115,000.00 per year for services
19		relating to the Nation's investment portfolio and the 401(k) retirement plan, ; and
20	WHEREAS,	the source of funds for the consultant fee will be the investment accounts of the
21		Nation.
22	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
23		1. Approves the continuation of Portfolio Evaluations, Inc., as the Investment
24		Consultant for the Nation.
25		2. Approves the consultant fees to be paid from the investment accounts of the
26	;	Nation.
27		3. Approves the Investment Consultant Contract with Portfolio Evaluations, Inc.,
28		substantially in the form attached hereto, for the period from October 1, 2010
29		through  September  30, 2011, and  authorizes  the  Chairman  of the  Nation  to  execute
30		it, provided that any amendments or extensions to the Investment Consultant
31		Contract shall be presented to the Legislative Council for further approval.
