11	reviewed the attorney contract with Steven Weatherspoon PLLC and recommend
12	approval by the Legislative Council.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
14	1. Approves the Attorney Contract with Steven Weatherspoon, PLLC, in the amount of
15	\$150,000.00 for the period October 1, 2010 to September 30, 2011, substantially in
