(Approving an Attorney Contract for FY2011 with the Law Firm of Gammage & Burnham PLC)

RESOLUTION NO. 10-423

1 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of Gammage**
2 **& Burnham PLC to represent the Tohono O'odham Nation in matters relating to the**
3 **West Valley Resort project; and**

4 **WHEREAS, the Attorney General has recommended a budget of \$100,000.00 for fiscal year 2011**
5 **for the period from October 1, 2010 to September 30, 2011; and**

6 **WHEREAS, the funding for this Attorney Contract will come from the FY2011 Economic**
7 **Development budget; and**

8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this**
9 **attorney contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with the**
12 **law firm of Gammage & Burnham PLC in the amount of \$100,000.00 for FY2011, for**
13 **the period from October 1, 2010 to September 30, 2011, substantially in the form**
14 **attached hereto.**
- 15 **2. Funding for the Attorney Contract will come from the FY2011 Economic**
16 **Development budget.**
- 17 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**
18 **Contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
20 **of OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
22 **VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
