6		and recommends a consultant contract for FY2011; and
7	WHEREAS	the term of the contract is for the period from October 1, 2010 to September 30, 2011,
	WILLIAM,	and the budget for the contract is \$30,000, to be funded by the FY 2011 operating

9		budget of the Office of Attorney General; and
10	WHEREAS,	the consultant contract has been reviewed by the Domestic Affairs and the Budget
11		and Finance Committees, which recommend approval by the Legislative Council.
12	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
13		Consulting Contract with Rocky Hill Advisors, Inc., in the amount of \$30,000, for the

15		hereto, and authorizes the Chairman of the Nation to execute it.
