

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Consulting Contract with Rocky Hill Advisors, Inc. for FY2011)**

RESOLUTION NO. 10-424

1 **WHEREAS, by Resolution No. 10-232 the Tohono O'odham Nation approved a consultant contract**
2 **with Rocky Hill Advisors, Inc., to serve as an expert in the trust mismanagement**
3 **lawsuits filed by the Tohono O'odham Nation against the United States in the federal**
4 **courts in Washington, D.C.; and**

5 **WHEREAS, the Attorney General continues to require the services of Rocky Hill Advisors, Inc.,**
6 **and recommends a consultant contract for FY2011; and**

7 **WHEREAS, the term of the contract is for the period from October 1, 2010 to September 30, 2011,**
8 **and the budget for the contract is \$30,000, to be funded by the FY 2011 operating**
9 **budget of the Office of Attorney General; and**

10 **WHEREAS, the consultant contract has been reviewed by the Domestic Affairs and the Budget**
11 **and Finance Committees, which recommend approval by the Legislative Council.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
13 **Consulting Contract with Rocky Hill Advisors, Inc., in the amount of \$30,000, for the**
14 **period from October 1, 2010 to September 30, 2011, substantially in the form attached**
15 **hereto, and authorizes the Chairman of the Nation to execute it.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
17 **of OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
19 **VI, Section 2 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
20 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat. 984).**
