

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY2011 with the Law Firm of Kilpatrick Stockton LLP)

RESOLUTION NO. 10-425

1 **WHEREAS, the Office of Attorney General continues to require the legal services of Kilpatrick**
2 **Stockton LLP in litigating the Nation's claims against the United States for trust assets**
3 **mismanagement; and**

4 **WHEREAS, the Attorney General has recommended a budget of \$150,000.00 for this purpose in**
5 **fiscal year 2011, for the period from October 1, 2010 to September 30, 2011; and**

6 **WHEREAS, the attorney contract will be funded from the budget of the Office of Attorney General,**
7 **account number 01-1031-810; and**

8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the attorney**
9 **contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 11 **1. Approves the attorney contract with the Kilpatrick Stockton LLP law firm in the**
12 **amount of \$150,000.00 for Fiscal Year 2011, for the period from October 1, 2010 to**
13 **September 30, 2011, substantially in the form attached hereto.**
- 14 **2. The attorney contract will be funded from the operating budget of the Office of**
15 **Attorney General, account number 01-1031-810.**
- 16 **3. Authorizes the Chairperson of the Nation to execute the contract and the attached**
17 **Fee Agreement.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
19 **of OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
21 **VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
