

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Attorney Contract for FY2011 with the Law Firm of Garvey Schubert Barer)**

**RESOLUTION NO. 10-426**

1 **WHEREAS, the Office of Attorney General continues to require the legal services of the law firm**  
2 **of Garvey Schubert Barer to represent the Tohono O'odham Nation in matters**  
3 **involving the KOHN-FM Radio Station and the Federal Communication Commission;**  
4 **and**

5 **WHEREAS, the Attorney General has recommended a budget of \$5,000.00 for FY2011 for the period**  
6 **from October 1, 2010 to September 30, 2011; and**

7 **WHEREAS, the funding for this Attorney Contract will come from the budget of the Office of**  
8 **Attorney General, account number 01-1031-810; and**

9 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this attorney**  
10 **contract and recommend approval by the Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 12 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with the**  
13 **law firm of Garvey Schubert Barer in the amount of \$5,000.00 for FY2011, for the**  
14 **period from October 1, 2010 to September 30, 2011, substantially in the form**  
15 **attached hereto.**
- 16 **2. Funding for the Attorney Contract shall be provided from the budget of the Office**  
17 **of Attorney General (01-1031-810).**
- 18 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**  
19 **Contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day**  
21 **of OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**  
23 **VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
