

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract for FY2011 with Paul J. Matte III)

RESOLUTION NO. 10-429

1 **WHEREAS, the Office of Attorney General continues to require the legal services of Paul J. Matte**
2 **III to represent the Tohono O'odham Nation in legal proceedings in Maricopa**
3 **County, Arizona, involving the Nation's interests under the Indian Child Welfare Act;**
4 **and**

5 **WHEREAS, the Attorney General recommends an Attorney Contract with Paul J. Matte III in the**
6 **amount of \$35,000 for Fiscal Year 2011, for the period October 1, 2010 to September**
7 **30, 2011; and**

8 **WHEREAS, the Domestic Affairs and Budget & Finance Committees have reviewed the attorney**
9 **contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with**
12 **Paul J. Matte III in the amount of \$35,000 for Fiscal Year 2011, for the period**
13 **October 1, 2010 to September 30, 2011, substantially in the form attached**
14 **hereto.**
- 15 **2. Funding for the Attorney Contract shall be from the budget of the Office of**
16 **Attorney General (Account No. 01-1031-810).**
- 17 **3. The Chairperson of the Nation is authorized and directed to execute the**
18 **Attorney Contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
20 **of OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 2,271.50 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and 324.0[05] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
