8		confirms the terms and conditions related to her services, a copy of which is				
9		attached hereto; and				
10	WHEREAS,	the Domestic Affairs Committee has recommended approval by the Legislative				
11		Council of a Conflict Attorney Contract with Belinda B. BreMiller on such terms.				
12	NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves the					
13		Conflict Attorney Contract for Belinda B. BreMiller in substantially the form				
14	attached hereto in an amount not to exceed \$60,000.					
15	BE IT FURTHER RESOLVED that the Contract shall become be effective as of October 1, 2010 and					
16	shall end September 30, 2011.					
17	BE IT FINALLY RESOLVED that the funding source for the Conflict Attorney Contract for Belinda					
18	B. Bremiller shall be provided under the operating budget of the Tohono O'odham					
19		Advocate Program for fiscal year 2011.
