

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY2011 Attorney Contract for Belinda B. BreMiller to Serve as Conflict Attorney)

RESOLUTION NO. 10-431

1 **WHEREAS, there is a need for attorneys to handle conflicts which the Tohono O'odham**
2 **Advocate Program is not ethically allowed to handle in regards to the increasing**
3 **needs of tribal members for legal representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to contract with Belinda B. BreMiller to represent**
5 **clients with conflicts who cannot be represented by the Nation's Advocate Program**
6 **due to the program's conflict of interest; and**

7 **WHEREAS, the Advocate Program has presented a contract for Belinda B. BreMiller which**
8 **confirms the terms and conditions related to her services, a copy of which is**
9 **attached hereto; and**

10 **WHEREAS, the Domestic Affairs Committee has recommended approval by the Legislative**
11 **Council of a Conflict Attorney Contract with Belinda B. BreMiller on such terms.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves the**
13 **Conflict Attorney Contract for Belinda B. BreMiller in substantially the form**
14 **attached hereto in an amount not to exceed \$60,000.**

15 **BE IT FURTHER RESOLVED that the Contract shall become be effective as of October 1, 2010 and**
16 **shall end September 30, 2011.**

17 **BE IT FINALLY RESOLVED that the funding source for the Conflict Attorney Contract for Belinda**
18 **B. Bremiller shall be provided under the operating budget of the Tohono O'odham**
19 **Advocate Program for fiscal year 2011.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
21 **of OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0-**
22 **AGAINST; 198.70[03]NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**


