2	Cardiovascular Risk Reduction Demonstration Project grant through FY 2010 with a
3	base budget of \$397,100.00; and
4	WHEREAS, Resolution Number 10-315, dated August 4, 2010, the Tohono O'odham Legislative
5	Council approved the Cardiovascular Risk Reduction Demonstration Project in the
6	amount of \$397,100.00 for FY 2011, which Resolution Number 10-315 needs to be
7	rescinded as FY2011 expected program funding was not approved; and
8	WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting a new
9	FY 2011 no-cost extension carry over budget in the amount \$106,603.00; and
10	WHEREAS, this budget represents the final close out for the Cardiovascular Risk Reduction
11	Demonstration Project grant; and
12	WHEREAS, in event the Cardiovascular Risk Reduction Demonstration Project does not receive
13	continuing funding for the renewal application for fiscal year 2012 the Tohono
14	O'odham Nation will not be obligated to continue funding.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby rescinds
16	Resolution Number 10-315, dated August 4, 2010 and further approves and authorizes
17	the FY 2011 no-cost extension carry over expenditures for CVD base budget in the
18	amount of \$106,603.00.
19	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
20	Chairperson and any designated official to expend and administer the budget as
21	attached, provided that any amendments affecting the funds or funding level shall be
22	submitted for further prior approval by the Tohono O'odham Legislative Council.
23	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>15TH</u> Day
24	of OCTOBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-
25	AGAINST;-0-NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article
26 27	VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
28	O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
