

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amend Enrollment Resolution No. 99-080)**

RESOLUTION NO. 10-440

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**
2 **ordinances for governing the enrollment and adoption of members and the**
3 **relinquishment and loss of membership" Constitution of the Tohono O'odham Nation**
4 **Article VI Section 1(h); and**

5 **WHEREAS, article VIII Section 1 of the Enrollment Ordinance No. 5-81 (as amended) provides that**
6 **the Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption; and**

8 **WHEREAS, on November 4, 2002 the Legislative Council pursuant to Resolution No. 02-508,**
9 **approved Martin Anguiano Martinez Roll No. 4896-S-02 for membership in the**
10 **Tohono O'odham Nation; and**

11 **WHEREAS, on October 10, 2005 the Legislative Council pursuant to Resolution No. 05-607**
12 **approved Martin Anguiano Martinez Roll No. 5206-S-05 for membership in the**
13 **Tohono O'odham Nation; and**

14 **WHEREAS, the Enrollment Committee had determined, based on the individual's date of birth,**
15 **and family tree, Martin Anguiano Martinez listed with Roll No. 4896-S-02 and 5206-S-**
16 **05 is the same individual; and**

17 **WHEREAS, the Enrollment Manual at pate 5, (*Filing of Applications*) provides that once a number**
18 **has been assigned to an application it shall not be changed; and**

19 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
20 **Legislative Council shall cause the membership roll be kept current.**

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

22 **1. The Tohono O'odham Legislative Council amends Resolution No. 99-080 as**
23 **follows:**

24 **The Roll No. listed for Martin Anguiano Martinez shall retain Roll No. 4896-S-02**
25 **to reflect the number originally assigned to the application of Martin Anguiano**
26 **Martinez on November 4, 2002 which was approved by this Council pursuant to**
27 **Resolution No. 02-508 and Amend Resolution 99-080 that the name Martin**
28 **Anguiano Martinez roll No. 5206-S-05 shall be removed.**

29 **2. The Enrollment Committee shall make the necessary changes in the records of**
30 **the Enrollment Office to incorporate the stated amendment.**

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD Day
2 of NOVEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-
3 AGAINST; -0- NOT VOTING; and 187.10 [07] ABSENT, pursuant to the powers vested in the Council
4 by Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the
5 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
7 18, 1934 (48 Stat. 984).
