**RESOLUTION NO. 10-445** 

1	WHEREAS,	on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the "Tohono
2		O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per
3		capita payments to the Nation's members provided that sufficient gaming revenues
4		are available; and
5	WHEREAS,	the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham
6		Nation ("Gaming Ordinance") was subsequently amended to authorize per capita
7		distribution payments in accordance with the Initiative (See Legislative Council
8		Resolution No. 97-303); and
9	WHEREAS,	the Legislative Council adopted the Per Capita Revenue Allocation Plan for a per
10		capita distribution per Legislative Council Resolution No. 09-164; and
11	WHEREAS,	the Chairman of the Nation received written notification from the Department of the
12		Interior on June 15, 2009 that the Nation's Revenue Allocation Plan is approved; and
13	WHEREAS,	the  Nation's  Department  of  Membership  Services, Enrollment  Program  submits  to  the  Membership  Services  and  Services
14		Tohono O'odham Legislative Council the certification Listing for eligible adult
15		members for review and approval for a fourth per capita distribution; and
16	WHEREAS,	pursuant to Resolution No. 09-428 which approved the Master List for certification,
17		the initial number of verified adult eligible members for the fourth per capita
18		distribution is 19,141; and
19	WHEREAS,	the disbursement of funds to each eligible adult member is contingent upon
20		verification of a member and further certification by the TohonoO'odhamLegislative
21		Council.
22	NOW, THER	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
23		the certification of $\underline{5}$ additional adult members for the fourth per capita distribution.
