3	WHEREAS, KOHN, as a member of NAMA, would like to be represented at this historic
4	presentation of the first Waila NAMA, and finds it necessary to provide funds to permit
5	a staff member to attend, and;
6	WHEREAS, KOHN management has prepared and presented the attached modification #1 of its
7	FY 2011 budget, incorporated into this resolution by this reference, to provide for the
8	allocation of funds to enable a staff representative to attend the awards presentation,
9	and;
10	WHEREAS, the modification re-allocates \$1,200.00 from the 700 - advertising account, to accounts
11	655 – lodging and 660 – travel expense, accounts that were not funded for fiscal year
12	2011, and;
13	WHEREAS, KOHN management has presented the attached modification #1 of its FY 2011 budget
14	to the Executive Office and appropriate oversight committees for review and a
15	recommendation for approval.
16	NOW, THEREFORE, BE IT RESOLVED, by the Tohono O'odham Legislative Council that it hereby
17	approves and authorizes modification #1 of KOHN 91.9 FM's FY 2011 budget to be
18	expended as attached.
19	BE IT FURTHER RESOLVED, by the Tohono O'odham Legislative Council that it approves re-
20	allocation of \$1,200.00 from the 700 - advertising account, to accounts 655 – lodging
21	and 660 – travel expense, accounts previously unfunded for fiscal year 2011, to provide
22	for a staff representative to attend the Native American Music Awards presentation.
23	BE IT FINALLY RESOLVED, by the Tohono O'odham Legislative Council that the Tohono O'odham
24	Nation's Officials to-wit: the Chairman, and any designated official, are authorized to
25	execute the budget modification, provided however, that any amendments affecting
26	the funds or funding levels of the budget shall be submitted for further prior approval
27	by the Tohono O'odham Legislative Council.
28	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>03RD</u> Day
29	of NOVEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,029.20 FOR; -0-
30	AGAINST; 204.70[02] NOT VOTING; and 361.60[08] ABSENT, pursuant to the powers vested in the
31	Council by Article VI, Section 1 (1) of the Constitution of the Tohono O'odham Nation, adopted by
32	the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
33	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
34	18, 1934 (48 Stat. 984).
