

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Matilda S. Juan to the Election Board for a Five-Year Term Expiring  
July 31, 2015)**

**RESOLUTION NO. 10-449**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**  
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**  
3 **committees, boards, officers and agents (Constitution of the Tohono O'odham Nation,**  
4 **Article VI, Section 1(b)); and**

5 **WHEREAS, under Ordinance No. 03-86, the Uniform Election Ordinance ("Election Ordinance")**  
6 **authorizes the Tohono O'odham Legislative Council to appoint members of the**  
7 **Tohono O'odham Election Board (Election Ordinance, Article II, Section 1(B)); and**

8 **WHEREAS, the Election Ordinance provides that board members shall be "appointed . . . for terms**  
9 **of five years, or until their successors are appointed and qualified" and further "that**  
10 **appointments to the board shall be made in such a way and for such terms that their**  
11 **terms shall be staggered so that the term of office of only one member will end in any**  
12 **single year." (Election Ordinance, Article II, Section 1(B)); and**

13 **WHEREAS, Ms. Matilda S. Juan was appointed by Resolution No. 05-613 for a term expiring on July**  
14 **31, 2010 and she continues to serve until her successor is appointed; and**

15 **WHEREAS, the Rules Committee has solicited and interviewed qualified bilingual members of the**  
16 **Nation to serve on the Election Board; and**

17 **WHEREAS, the Rules Committee recommends that Matilda S. Juan be appointed to the Election**  
18 **Board for a term expiring July 31, 2015.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
20 **the appointment of Matilda S. Juan to the Election Board beginning on the effective**  
21 **date of this resolution and expiring July 31, 2015; provided that she shall continue to**  
22 **serve until replaced by a successor who has been appointed and qualified.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> Day**  
24 **of NOVEMBER, 2010 at a meeting at which a quorum was present with a vote of 1,634.80 FOR; -0-**  
25 **AGAINST; 449.60[02] NOT VOTING; and 511.10[08] ABSENT, pursuant to the powers vested in the**  
26 **Council by Article VI, Section 1(b) and Article X, Section 7 of the Constitution of the Tohono**  
27 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by**  
28 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
29 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
