

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Submission of Legislative Committee Quarterly Reports)**

LEGISLATIVE ORDER NO. 10-450

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**  
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**  
4 **Section 1(a)); and**

5 **WHEREAS, pursuant to Article XI, Section 1(A) of the Legislative Rules, there are 13 standing**  
6 **committees of the Tohono O'odham Legislative Council whose memberships are**  
7 **comprised of representatives to the Legislative Council (Rules of the Legislative**  
8 **Council ("Legislative Rules")); and**

9 **WHEREAS, the duties and powers of all Legislative Council committees are prescribed under**  
10 **individual committee plans of operations that have been adopted by the Legislative**  
11 **Council and more generally under Article XI, Section 3 of the Legislative Rules; and**

12 **WHEREAS, as a matter of practice, all legislative committees provide committee reports to the**  
13 **full Legislative Council on a quarterly basis regarding matters within the committees'**  
14 **specific responsibilities and areas of oversight; and**

15 **WHEREAS, the Rules Committee recommends that Legislative Committees continue to submit**  
16 **committee reports on a quarterly basis in written form to the full Legislative Council.**

17 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that Legislative**  
18 **Committees submit committee reports on a quarterly basis in written form to the full**  
19 **Legislative Council.**

20 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> day of**  
21 **NOVEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,084.40 FOR; -0-**  
22 **AGAINST; [01] NOT VOTING; and 511.10[08] ABSENT, pursuant to the powers vested in the Council**  
23 **by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**  
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**


