5	WHEREAS, pursuant to Article XI, Section 1(A) of the Legislative Rules, there are 13 standing						
6	committees of the Tohono O'odham Legislative Council whose memberships are						
7	comprised of representatives to the Legislative Council (Rules of the Legislative						
8	Council ("Legislative Rules")); and						
9	WHEREAS, the duties and powers of all Legislative Council committees are prescribed under						
10	individual committee plans of operations that have been adopted by the Legislative						
11	Council and more generally under Article XI, Section 3 of the Legislative Rules; and						
12	WHEREAS, as a matter of practice, all legislative committees provide committee reports to the						
13	full Legislative Council on a quarterly basis regarding matters within the committees'						
14	specific responsibilities and areas of oversight; and						
15	WHEREAS, the Rules Committee recommends that Legislative Committees continue to submit						
16	committee reports on a quarterly basis in written form to the full Legislative Council.						
17	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that Legislative						
18	Committees submit committee reports on a quarterly basis in written form to the full						
19	Legislative Council.
