

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Office on Violence Against Women (OVW) grant under the grant to
Indian Tribal Governments Program for \$900,000.00 for three years FY2011)

RESOLUTION NO. 10-451

1 **WHEREAS, the Department of Health and Human Services, Management of Health Division**
2 **coordinates services provision for its ten divisions; and**

3 **WHEREAS, the Tohono O'odham Nation submitted an application to the Office of Violence**
4 **Against Women (OVW) for funding under the Grants to Indian Tribal Governments**
5 **Program in the amount of \$900,000.00 for the next 36 months; and**

6 **WHEREAS, the Tohono O'odham Nation has been awarded Grant No. 2010-TW-AX-0020 from the**
7 **Department of Justice for a three year grant project period 10/01/10 - 09/30/13 to**
8 **provide crisis intervention for Tohono O'odham women who are victims/survivors**
9 **of domestic violence and educate the community on domestic violence, dating**
10 **violence, sexual assault and stalking; and**

11 **WHEREAS, the Violence Against Women Award of \$900,000.00 will be divided by \$300,000.00 over**
12 **the three years; and**

13 **WHEREAS, a budget of \$300,000.00 has been prepared for Fiscal Year 2011.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts,**
15 **approves and authorizes:**

- 16 **1. The acceptance of Grant award No. 2010-TW-AX-0020 in the amount of**
17 **\$900,000.00 from the Department of Justice/Office of Violence Against Women for**
18 **the period of 10/01/10 to 9/30/13.**
- 19 **2. A budget of \$300,000.00 for Fiscal Year 2011 attached hereto and incorporated**
20 **herein is approved and authorized to expend accordingly by the Tohono**
21 **O'odham Legislative Council.**
- 22 **3. New budgets for \$300,000.00 for FY2012 and FY2013 shall be presented to the**
23 **Legislative Council for further prior approval.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **Chairperson and any designated official to expend and administer the FY2011 budget as**
26 **attached hereto, provided that any amendments affecting the funds or funding level shall**
27 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**


