

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Sif Oidak District FY 2010 Home Repair/Renovation Carryover  
Budget in the amount of \$266,596.95 to FY 2011)**

RESOLUTION NO. 10-456

1 **WHEREAS, the Sif Oidak Council passed Resolution No. SODC-10-187, "Approving the FY 2010 Sif**  
2 **Oidak District Home Repair/Renovation Carryover Budget to FY 2011"; and**

3 **WHEREAS, the unexpected delay in expending the funds was due to the actual surveys that were**  
4 **being conducted; and**

5 **WHEREAS, the majority of the home surveys have been completed to date which will assist the**  
6 **District in the selection process for the homes that will be repaired or renovated; and**

7 **WHEREAS, the amount of \$266,596.95 is the original amount allocated and there have been no**  
8 **funds expended to date.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**  
10 **approve the Sif Oidak District FY 2010 Home Repair/Renovation Carryover Budget in**  
11 **the amount of \$266,596.95 to FY 2011.**

12 **BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels of the**  
13 **attached budget shall be submitted for further prior approval by the Tohono**  
14 **O'odham Legislative Council.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
16 **of NOVEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-**  
17 **AGAINST; -0-NOT VOTING; and 187.10[06] ABSENT, pursuant to the powers vested in the Council by**  
18 **Article VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
19 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**
