

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with The Clark Law Firm)

RESOLUTION NO. 10-457

1 **WHEREAS, it is advisable that the Human Resources Office has available independent legal**
2 **representation for employment issues in which the Office of Attorney General is**
3 **unable to provide legal advice due to conflicts of interest; and**

4 **WHEREAS, the Human Resources Office recommends an Attorney Contract with The Clark Law**
5 **Firm to provide legal representation to the Human Resources Office for the foregoing**
6 **purposes; and**

7 **WHEREAS, the proposed Attorney Contract is in the amount of \$15,000 for the period from**
8 **October 01, 2010 through September 30, 2011; and**

9 **WHEREAS, the operating budget for the Human Resources Office (Account No. 01-1005-810) for**
10 **fiscal year 2011 includes sufficient funds for the Attorney Contract; and**

11 **WHEREAS, the Domestic Affairs Committee, Human Resources Development Committee and the**
12 **Budget and Finance Committee recommends approval by the Legislative Council of**
13 **an attorney contract.**

14 **NOW, THEREFORE, BE IT RESOLVED that:**

- 15 **1. The Tohono O'odham Legislative Council hereby approves an attorney contract**
16 **with The Clark Law Firm in the amount of \$15,000 for the Fiscal year ending**
17 **September 30, 2011, substantially in the form attached hereto.**
- 18 **2. Funding for the Attorney Contract in Fiscal Year 2011 shall be provided under the**
19 **operating budget of the Human Resources Office (Account No. 01-1005-810).**
- 20 **3. The Chairman of the Nation is authorized and directed to execute the Attorney**
21 **Contract.**


22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day**

25 **Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
