

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Accepting Certification of Eligible Adult Members and Authorizing the Initial  
Expenditure of Funds for Per Capita Payments under the Second Per Capita Plan)**

**RESOLUTION NO. 10-466**

1 **WHEREAS, on June 28, 1997 the voters of the Tohono O'odham Nation approved Initiative No IN-**  
2 **01-97 (the "Initiative"); and**

3 **WHEREAS, pursuant to Initiative and Resolution Nos. 97-451 and 97-452 the Tohono O'odham**  
4 **Legislative Council adopted an Initiative Funding and Implementation Plan and**  
5 **Revenue Allocation Plan (collectively the "First Per Capita Plan"); and**

6 **WHEREAS, an initial Per Capita Distribution under the first Per Capita Plan was approved on**  
7 **December 18, 1997 by the Phoenix Area Office of the Bureau of Indian Affairs; and**

8 **WHEREAS, initial Per Capita distribution have been and continue to be disbursed to Adult**  
9 **Eligible members under the first Per Capita Plan; and**

10 **WHEREAS, pursuant to the Initiative Resolution No. 2000-269 and 2000-472, the Legislative**  
11 **Council adopted (1) a Second Initiative Funding and Implementation Plan, (2) a**  
12 **Second Revenue Allocation Plan, and (3) Amendment No. 1 to each Plan (collectively**  
13 **the "Second Per Capita Plan"); and**

14 **WHEREAS, under the second Per Capita Plan each eligible member who is certified as eligible is**  
15 **entitled to receive a per capita payment of \$2,000.00; and**

16 **WHEREAS, by letter dated October 25, 2000 the Deputy Commissioner of Indian Affairs approved**  
17 **the Second Per Capita Plan; and**

18 **WHEREAS, as required by the Second Per Capita Plan, the Attorney General of the Nation issued**  
19 **a Notice of Compliance on October 26, 2000; and**

20 **WHEREAS, as required by the Second Per Capita Plan the Enrollment Office has filed a**  
21 **certification of Eligible Members listing 01 eligible adult Members who are eligible**  
22 **for receipt of a per capita payment under the terms of the Second Per Capita Plan and**  
23 **the applicable laws of the United States and the Nation.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 25 **1. Accepts and approves the certification listing for 01 Eligible Adult Members for**  
26 **the Second Per Capita approved listing payout distribution.**
- 27 **2. Authorizes (a) the transfer of \$2,000.00 from the Second Per Capita Investment**  
28 **Account to the Second Per Capita Checking Account established at Bank of**  
29 **America; and (b) upon the authorized signature of the Nation, issuance of a check**  
30 **on the Second Per Capita Checking Account in the amount of (I) \$2,000.00 to each**

1 Eligible Member residing in the United States and listed in the Certification Listing  
2 of Eligible Members and (ii) \$1,400.00 to each Eligible Member residing outside  
3 the United States and listed in the Certification Listing of Eligible Members, with  
4 the balance of \$600.00 withheld and remitted to the Internal Revenue Service  
5 pursuant to the requirements of federal law.

6 3. Authorizes the Chairman of the Nation to execute such other documents as may  
7 be necessary to implement this Resolution.

8 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of  
9 funds to each additional eligible adult Tohono O'odham member is contingent upon  
10 verification of a member by the Enrollment Program and further certification of  
11 additional eligible adult members by the Tohono O'odham Legislative Council

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day  
13 of DECEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-  
14 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
15 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by  
16 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18 18, 1934 (48 Stat. 984).
