

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Department of Justice Office of Justice Program Project Safe Neighborhood
Indian Country Pilot Program budget for FY 2011 in the amount of \$150,000.00)

RESOLUTION NO. 10-474

1 WHEREAS, the Tohono O'odham Nation Police Department (TONPD) was awarded and
2 successfully accepted the Department of Justice Office of Justice Program Project
3 Safe Neighborhood Indian Country Pilot Program grant number 2009-GP-BX-0096
4 per resolution number 09-553; and

5 WHEREAS, the funding for this grant period is effective August 1, 2009 through July 31, 2012; and

6 WHEREAS, the TONPD is carrying this budget over into the FY 2011 budget year; and

7 WHEREAS, the TONPD has created a budget with line items in personnel Other compensation &
8 Fringe Benefits; Operational for training/travel cost, supplies, supplies other,
9 consultants and major capital; and

10 WHEREAS, the grant does not allow for Indirect Cost.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
12 approves the budget for the FY 2011 Department of Justice, Office of Justice Programs
13 Project Safe Neighborhood Indian Country Pilot Program Grant in the amount of
14 \$150,000.00 with no indirect cost charges effective August 1, 2010 through July 31,
15 2011.

16 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the
17 Chairperson and any designated official to expend and administer the budget as
18 attached, provided that any amendments affecting the funds or funding level shall
19 be submitted for further prior approval by the Tohono O'odham Legislative Council.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day
21 of DECEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,411.0 FOR; -0-
22 AGAINST; 184.50 [03] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council
23 by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the
24 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
26 18, 1934 (48 Stat. 984).
