

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District FY 2011 Budget Amendment #1 for Sikol Himatk Community)**

RESOLUTION NO. 10-476

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on December 6, 2010 to address**
2 **issues pertaining to the Nation; and**

3 **WHEREAS, on November 20, 2010 at a regularly scheduled meeting, the Gu Achi District Council**
4 **did approve a budget amendment for Sikol Himatk Community (*Amendment #1,***
5 ***Resolution #1110-338*); and**

6 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review**
7 **the community's budget amendment submitted by the Gu Achi District and**
8 **recommend for approval.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
10 **approve the Gu Achi District FY 2011 Budget Amendment #1 for Sikol Himatk**
11 **Community.**


12 **BE IT FURTHER RESOLVED that the amendment does not affect the overall portion of the Gaming**
13 **Distribution of \$1,705,922.80 allocated to the Gu Achi District.**

14 **BE IT FURTHER RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal**
15 **Year 2011 budget in accordance with protocols set forth by this Council. Any**
16 **amendments affecting the funds or funding levels of the Gu Achi District's Fiscal Year**
17 **2011 budget shall be approved by the Tohono O'odham Legislative Council.**

18 **BE IT FINALLY RESOLVED that this resolution will be executed in an expedient manner.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
20 **of DECEMBER, 2010 at a meeting at which a quorum was present with a vote of 2,145.90 FOR; -0-**
21 **AGAINST; 449.60[03]NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**
22 **by Article VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**
