

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving a Christmas Bonus for Employees of the Executive Branch, Judicial Branch  
and the Legislative Branch including all Appointed and Elected Officials of the  
three Branches)**

**RESOLUTION NO. 10-477**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage any**  
2 **funds within the exclusive control of the Tohono O'odham Nation" (Constitution of**  
3 **the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

4 **WHEREAS, the Tohono O'odham Nation (the "Nation") has prepared a proposal for a Christmas**  
5 **Bonus to each employee of the Executive Branch, Judicial Branch and the Legislative**  
6 **Branch including all Appointed and Elected Officials of the three Branches based on**  
7 **years of service to the Nation; and**

8 **WHEREAS, for the purpose of this legislative action, a Christmas Bonus is defined as a sum of**  
9 **money granted to an employee in addition to a regular pay; and**

10 **WHEREAS, it is proposed that, as of December 1, 2010, employees with a year or more of service**  
11 **to the Nation shall receive \$500.00, employees with less than a year of service to the**  
12 **Nation shall receive \$250.00, and employees hired on or after December 1, 2010 shall**  
13 **not be eligible to receive a Christmas Bonus; and**

14 **WHEREAS, the proposal was presented to the Legislative Budget and Finance Committee for**  
15 **consideration.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
17 **approves a Christmas Bonus for employees of the Executive Branch, Judicial Branch**  
18 **and the Legislative Branch including all Appointed and Elected Officials of the three**  
19 **Branches.**

20 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that this payment be issued**  
21 **on the date of December 17, 2010.**

22 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that this payment be issued**  
23 **with the following criteria:**

- 24 **1) Current employees and officials with a year or more of service to the Nation as**  
25 **of December 1, 2010 shall be eligible to receive \$500.00.**
- 26 **2) Current employees and officials with less than a year of service to the Nation as**  
27 **of December 1, 2010 shall be eligible to receive \$250.00.**
- 28 **3) Current employees hired on or after December 1, 2010 shall not be eligible to**  
29 **receive a Christmas Bonus.**


1 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council appropriates from FY

9 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
10 **Nation Chairman, Vice Chairman, and any designated officials are authorized to**  
11 **execute this resolution, provided that any amendments affecting the funds or funding**  
12 **levels shall be submitted for prior approval by the Tohono O'odham Legislative**  
13 **Council.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day**  
15 **of DECEMBER, 2010 at a meeting at which a quorum was present with a vote of 1,523.85 FOR;**  
16 **1,071.65 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**  
17 **by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
18 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
20 **18, 1934 (48 Stat. 984).**
