**RESOLUTION NO. 15-001**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
11 **approving applicants for membership contain misspellings in the names of**  
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 334-88, 94-**  
14 **504, 96-260, 96-514, 97-105, 97-460, 98-492, 99-140, 99-311, 2000-003, and 2000-**  
15 **176 be amended to reflect the correct name spelling or roll numbers for the**  
16 **individuals identified in the Amending Enrollment Resolution List January 2015,**  
17 **which is incorporated by this reference; and**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
19 **Resolution Nos. 334-88, 94-504, 96-260, 96-514, 97-105, 97-460, 98-492, 99-140, 99-**  
20 **311, 2000-003, and 2000-176 are amended upon the effective date of those**  
21 **resolutions to reflect the corrected names or roll numbers that are identified in**  
22 **the Amending Enrollment Resolution Amended List January 2015.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
24 **day of JANUARY, 2015 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;**  
25 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
27 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
28 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
29 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
