11		approving applicants for membership contain misspellings in the names of
12		applicants; or incorrect roll numbers; and
13	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 334-88, 94-
14		504, 96-260, 96-514, 97-105, 97-460, 98-492, 99-140, 99-311, 2000-003, and 2000-
15		176 be amended to reflect the correct name spelling or roll numbers for the
16		individuals identified in the Amending Enrollment Resolution List January 2015,
17		which is incorporated by this reference; and
