4	WHEREAS,	the amount of solid waste from the Nation that is disposed of in the City of			
5		Tucson's Los Reales Landfill is more than 4,000 tons annually costing the Nation			
6		at least \$116,000.00 annually; and			
7	WHEREAS,	the Nation can enter into a "Put or Pay Agreement" with the City of Tucson which			
8		enables the Nation to reduce its disposal costs from \$32.00/ton to \$29.00/ton if			
9		the Nation guarantees to deliver at least 4,000 tons annually thereby saving at			
10		least \$12,000.00 annually; and			
11	WHEREAS,	the Solid Waste Management Program has delivered more than 4,000 tons			
12		annually for the past six years; and			
13	WHEREAS,	put or pay Professional Services Agreement has been reviewed by the Attorney			
14		General's Office, the Agricultural and Natural Resources Committee and the			
15		Budget and Finance Committee of the Legislative Council and they recommend			
16		its approval.			
17	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and				
18		approves the City of Tucson Waste Delivery/Disposal agreement substantially in			
19		the form attached hereto.

21		Chairperson to execute the agreements, provided that any amendment affecting			
22		the Professional Services Agreement is submitted for further prior approval by
